
ERC1155 Standard:

Priceless has chosen the ERC1155 token, which allows for a variety of options when fractionalizing the assets, which can be tailored to different asset classes.

Example workflow:

A rare collectible watch worth **\$1 million** is authenticated and tokenized as an **ERC1155** token Priceless.







Priceless Fractionalization Engine (PFE)


Fractional Ownership Model:

The PFE builds on tokenization by dividing highvalue assets into smaller, more affordable units, with each fraction representing a proportional share of ownership.

Example workflow:

Step 1:

A collectible art print valued at **\$250,000** is tokenized into **1,000 ERC1155** tokens, each representing 0.1% ownership.





Technology Overview III:

RWA Trading Marketplace

Unlocking Liquidity:

By creating a liquid secondary market for traditionally illiquid assets, the marketplace allows investors to enter or exit positions with ease.

Example Workflow for RWA Trading Marketplace:

Step 1:

An investor owns **100 tokens** of a fractionalized designer handbag worth **\$100,000.**



Step 3:

A buyer purchases the tokens directly through the platform using **\$PRICE** tokens.

Step 2:

The investor lists **50 tokens** for sale on the Priceless marketplace at **\$120 per token**, reflecting an increase in the handbag's value.

AI Grading Tech

Standardized Valuations:

The grading score provides a standardized measure for helping arrive at valuations of assets. The AI models are updated constantly as the database grows.

Example Workflow for AI Grading:

Step 1:

A collectible trading card is submitted for tokenization on the Priceless platform.







AI-DRIVEN ROBOGRADING TECHNOLOGY: ROBOGRADE USES A LAB-GRADE LASER SYSTEM AND 4K CAMERA TO CAPTURE DATA ABOUT ASSETS. IT THEN RUNS AI MODELS TO ANNOTATE THE DATA, AND USES ALGORITHMS TO DERIVE A GRADING SCORE BASED ON THE ANNOTATIONS.







Roadmap

Stage 1 (Q1 2025):

Buying & Selling Of Assets Using \$PRICE Tokens

In the first stage, \$PRICE tokens will be integrated into the existing TCG Grader app as the exclusive payment option for purchasing assets. This will establish the initial customer base of high net-worth individuals before the blockchainbased and RWA-tokenized version of the Priceless app is launched.

Stage 2 (Q2 2025):

Launch Of RWA-Tokenized dApp

Once this initial customer-base has been established, Priceless will then launch the blockchain-based RWAtokenized marketplace, which will allow users to buy fractional shares of assets and introduce deeper levels of decentralization. This will initially focus on collectibles and luxury goods.



Step 3 (Q3 2025):

Expansion Into New Verticals

Once the decentralized RWAtokenization model has been proven out for the collectibles and luxury goods verticals, Priceless will expand to introduce its tokenized private equity and hedge fund products, capitalizing on its established user base of high networth individuals.



The \$PRICE Token

A Unified Currency For Decentralized Alternative Investments:

\$PRICE tokens are the fuel on which the Priceless platform runs, providing a unified currency for the tokenized, fractionalized and decentralized RWA-trading of alternative investment assets.

Powering RWA-Trading:

All payments for asset purchases on Priceless are taken in \$PRICE tokens, allowing for cross-border, global transactions that are private, secure and decentralized.

RWA-Tokenized Marketplace For \$16T Alternative Assets Industry:

USD-Pegged Pricing Mechanics:

Collectibles on the marketplace will have a price pegged to a USD value and buyers will pay the equivalent amount in \$PRICE tokens based on the market value of \$PRICE at time of purchase.





The marketplace will have a fiat on-ramp that allows users to convert fiat to USDT that can then be directly zapped into \$PRICELESS for product purchases via the USDT > \$PRICE zapper.







Revenue Model

Liquidity Bottlenecks:

Priceless operates a simple, scalable revenue model whereby a 10% fee is taken on all buys / sells within the Priceless RWA-trading marketplace.

Competitive Rates:

This undercuts commissions taken on most alternative investment asset classes whilst ensuring a robust revenue stream for the protocol.

Clear Upsell Opportunities:

Once the client-base of high networth individuals has been established through the luxury goods and collectibles products, Priceless will have an unrivalled customer base to pitch its tokenized private equity and hedge fund products to.
